Mr. Burge:

In Order No. PSC-01-1574-PAA-WS, issued July 30, 2001, in Docket No. 000584-WS, the Commission authorized a phase II rate for the customers located in Palm Circle Park. This rate would become effective after the utility has installed a wastewater meter at the Palm Circle Park connection and submitted revised tariff sheets reflecting the phase II rate, provided the customers have received notice. Although Laniger has already met the Commission's noticing requirements, staff believes that it would be in the interest of customer relations to notify the Palm Circle Park residents before billing the phase II rates.

Enclosed is an example of a revised phase II tariff sheet for this utility. Although staff has prepared the revised tariff for this utility, it is the utility's responsibility to make sure all tariffs submitted to the Commission are complete and accurate.


