NOTICE TO CUSTOMERS

The Florida Public Service Commission recently completed an investigation of rates and charges for the Aloha Gardens water and wastewater systems. Pursuant to Proposed Agency Action (PAA) Order No. PSC-01-1245-PAA-WS, issued on June 4, 2001 the Commission ordered the Utility to refund 1.14% of water revenues and 5.53% of wastewater revenues collected between January 18, 2000 and June 28, 2000. In addition, the Utility is required to refund 5.7% of water revenues and 6.42% of wastewater revenues collected for the period of June 29, 2000 up through the effective date of the rate reduction for these two systems as outlined below. Finally, as a result of a settlement of a protest of that Order, Aloha agreed to refund an additional \$12,000 above the ordered amounts.

Also as part of PAA Order No. PSC-01-1245-PAA-WS, the Utility is required to implement slight rate reductions for both the Aloha Gardens water and wastewater systems. Subsequent to the issuance of the above noted Order, the Utility implemented a 2001 price index. Based on the above noted Order, and the 2001 price index increase, the net effect on rates will be reductions of 4.98% for water, and 5.97% for wastewater. The new rates are reflected under the heading "new rates" in the schedule attached hereto.

PAA Order No. PSC-01-1245-PAA-WS was finalized by Order No. PSC-01-1672-AS-WS issued on August 16, 2001.

These new rates will go into effect on September 20, 2001, and will appear on your bills rendered 30 days on or after that date. The Utility is required by Commission rule to complete refunds (as credits to your next 3 bills) within 90 days of August 16, 2001.
