Tallahassee Memorial Telephone Company ~ Docket No. 011129-TX Re: Payment of Year 2000 RAF; Settlement Offer to Close Docket

Dear Ms. Bayó:

On August 22, 2001, the Florida Public Service Commission ("FPSC" or "Commission") opened the above-referenced docket to cancel the Alternative Local Exchange Telecommunications Certificate (No. 4717) issued to Tallahassee Memorial Telephone Company ("TMTC") for failure to pay its 2000 Regulatory Assessment Fee ("RAF") as required by Rule 25-4.0161. TMTC has yet to commence service and believed that the assessment of regulatory fees was based on the carrier's telecommunications revenue. Because TMTC had no telecommunications revenue in Year 2000, it thought that no RAF was due. The company recently was informed that there is a minimum RAF of fifty dollars (\$50.00) imposed on all certificate holders. As a result, TMTC has taken steps to ensure that its applicable RAF will be paid in future years by appointing this firm to monitor the FPSC's rules and compute and file all required regulatory fees.

TMTC wishes to retain its Alternative Local Exchange Telecommunications Certificate and requests that the Commission close the docket to cancel its certificate. We understand that the Commission has assessed up to \$500 against carriers that have engaged in egregious and/or repeated violations of FPSC rules. The instant docket is the first ever opened against TMTC. We believe that an assessment of \$100 is more commensurate with the nature of the current situation and the fact that the Commission has never opened a docket against the company. If the Commission accepts the foregoing assessment, TMTC hereby waives objection to the administrative cancellation of the

company's Alternative Local Exchange Telecommunications Certificate in the event that TMTC fails to comply with the payment of the proposed \$100 amount.

On September 10, 2001, Tashir Lee spoke to Paula Isler of the FPSC to determine the RAF TMTC owes for Year 2000. Ms. Isler indicated that TMTC owes \$66.50 (\$50.00 minimum RAF, \$12.50 penalty, and \$4.00 interest). A check for that amount and the accompanying RAF return form is enclosed. Finally, assuming that you agree with the proposed assessment amount, we have also enclosed a check in the amount of \$100.00.
