First I want to apologize for our nonpayment of the 2000 Regulatory Assessment Fee (RAF) which was due January 30, 2001, and make a settlement offer to the Commission.

I wish to pay the Regulatory Assessment Fee (RAF) of \$50 since Public Telephone Network, Inc. did not have any revenues in 2000, the \$12.50 penalty, and \$4.00 interest. I am enclosing our check for \$66.50.

Additionally I would like to offer a monetary settlement of \$250 fine for this rule violation.

This confusion has been brought about because of the chaos of getting our company started. We have been licensed for sometime, but our doors will finally open for business Monday, October 1, 2001 and all our records and business will be housed at our 6015 NW 7th Ave. address. We do not feel there will be any recurrence of not filing proper and timely reports in the future.

Our company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with the settlement offer.
