Dear Ms. Bayo:

Teligent Services, Inc. ("Old TSI") and TAC License Corp. ("TAC License" or "New TSI") (together "Applicants"), through their undersigned counsel, hereby clarify that the approval sought by their letter Application to the Commission dated September 5, 2001 ("Application"), which has been assigned Docket No. 0011286-TP by the Commission, included a request for assignment of the certificates currently held by Old TSI to new TSI.

In their Application, Applicants requested that the Commission grant such authority as may be necessary or required to enable Old TSI to consummate a transaction arising out of its Chapter 11 status which will enable its current Florida operations to continue without further interruption through a new "Teligent" corporate entity. Based on a conversation with Commission Staff, the Applicants understand that the transaction described in that Application will require, among other things, Commission approval of the assignment of Old TSI's certificates to New TSI. Accordingly, Applicants hereby clarify that they request that the Commission assign the following certificates to new TSI:

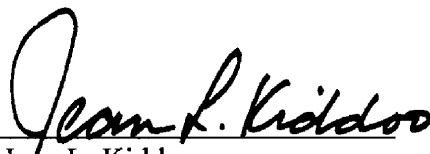

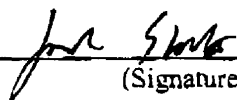
