REQUEST FOR TEMPORARY PROTECTIVE ORDER**


Comes now Talk America, Inc., f/k/a Talk.com Holding Corp. d/b/a Network Services d/b/a The Phone Company and The Other Phone Company d/b/a Access One Communications ("Talk America" collectively) pursuant to section 364.183, Florida Statutes, and Rule 25-22.006(6) and amends its request for a temporary protective order filed September 24, 2001, and states:

1. On September 24, 2001, Talk America submitted objections and responses to the Citizens First Set of Interrogatories and Third Set of Request for Production of Documents. At the same time, Talk America filed a Request for Temporary Protective Order as to the documents provided to Citizens.

2. Talk America has supplemented its response to Item 1 of the Interrogatories on October 5, 2001. In the supplemental response, Talk America incorporated its objection filed September 24, 2001 and herewith amends its Request for Temporary Protective Order filed September 24, 2001, to include the response and documents to Interrogatory No. 1 provided to the Office of Public Counsel on October 5, 2001.


