- **ISSUE 2:** What are the estimated environmental cost recovery true-up amounts for the period January, 2001 through December, 2001?
- GULF: Over recovery \$684,892. (Vick, Ritenour)
- **ISSUE 3:** What are the total environmental cost recovery true-up amounts to be collected/refunded during the period January 2002 though December 2002?

Billing cycles may start before January 1, 2002, and the last cycle may be read after December 31, 2002, so that each customer is billed for twelve months regardless of when the adjustment factor became effective.
