
Dear Ms. Bayó:



Bryan - as I indicated yesterday I believe both parties could have done a better job of communication regarding this NJ customer. I think this series of notes bears out that concern. I'd like to work with you to see if we can't make some improvements by scheduling a meeting with you, in the near future, to discuss mutual expectations regarding traffic termination, existing agreements and MCI local entry into Sprint LTD areas. This is an area between our companies that has, historically, more often than not resulted in escalation and/or miscommunication.

I'm sure both of us have very busy schedules. I think we could cover the issues in 2 - 3 hour session that sets a baseline from both perspectives and gives our teams the direction they need to ensure we manage this area of our business outside of emergency situations. Over the next few weeks I could travel to Atlanta for mid-day or afternoon meetings on the following dates:

- May 31st
- June 1st
- June 14th
- June 15th
- June 16th
- June 22nd
- June 28th

Please let me know as soon as possible if you want to meet and which, if any, of these dates would work.

In regards to the customer in NJ we are still attempting to move this "order" forward outside of our normal channels. We'll keep your team informed of progress or setback as they may occur. I expect a positive outcome.

Brian is out this morning at a meeting. Lets not confuse this order/request with a past escalation. I don't need an escalation from the fields perspective or the centers perspective. We have waited several months on this order, the T1 order has been complete since January. Our escalation is to have Sprint accept and process the order and close the legal gaps that have delayed this order. If the center and field needs to give us a normal FOC interval, I can work with that. How much time do they need? Lets not let the field knock us off track just before we finish this one. If they can do the order quickly, all the better.

You are correct in using the Florida BAN and tax exempt. David, if tax exempt is wrong, let us know. David is faxing you the certification.

Is there any other issues we need to be aware of that will put this order in jeopardy?

Brian,
It is essential that Sprint receives a copy of your CLEC certification today. It is not customary for Sprint to verify CLEC certification at PUC websites, however, I made an exception in this case and have verified that MCI is listed as a Local Exchange Carrier on the New Jersey state website you provided. Our field personnel have agreed to expedite your request, but stressed the requirement of the CLEC certification being in

hand.

You did not indicate whether you were using the same OCN and whether you are tax exempt. We are proceeding with the same OCN as Florida, with no tax exemption.

Our field people have been reluctant to expedite this request because of the situation that occurred a couple of months ago. If you recall, we expedited orders for you, stayed two hours overtime, and MCI failed to show for the handoff. The order was rescheduled for the next day and once again, MCI did not meet the appointment. It took three times for MCI to meet the date after Sprint had worked diligently to accommodate your needs. These situations are difficult to forget.

We certainly want to continue in a spirit of cooperation, and are making every effort to assist you in processing this latest emergency. I expect to have the amendment from our attorney today and will forward it as soon as it is received. I will keep you posted as we move forward to work your order. Brian,

In addition to the customer detail you are faxing to me, I need the following information so we can process your orders for LNP in New Jersey:

1. Will MCI use the same OCN they are using for Florida and/or North Carolina?
2. If yes, please send a copy of your state CLEC certification in New Jersey.
3. In addition, if you have a tax exemption in New Jersey, please provide a copy.

If the answer to number one is no, and you plan to use a different OCN, there are nine other documents that are required. I will send those to you electronically if needed.

I am working with our attorney on the addendum to the existing agreement and will send that to you as soon as it is available.

We will make every effort to process the LNP orders we receive today prior to the addendum being signed. However, please understand that Sprint is making a one time exception and the addendum will need to be signed before additional orders will be worked in New Jersey.
