Dear Ms. Lezcano:

This Commission has received your company's applications for Interexchange Telecommunications Service (IXC) and Alternative Local Exchange Service (ALEC). A review of the applications revealed that you neglected to mention your previous connection as officer and director to Worldlink Long Distance Corp.

According to our records Worldlink's IXC certificate was cancelled in Docket No. 000219-TX, Initiation of Show Cause Proceedings against Worldlink Long Distance Corp. for apparent violation of Section 364.183(1), F.S., Access to Company Records and Worldlink's ALEC certificate was cancelled in Docket No. 001301-TI, Cancellation by Florida Public Service Commission of IXC Certificate No. 5350 issued to Worldlink Long Distance Corp. for Violation of Rule 25-4.0161, F.A.C., Regulatory Assessment Fees.

In your ALEC application you neglected to complete Section 2, Rules and Regulations, of your Price List, instead, you simply left in the instructions provided in the Price List example. This must be completed.

According to the Florida Department of State, Division of Corporations, A+ Communications, Inc. was administratively dissolved for not filing an annual report. Staff cannot recommend an application of an invalid corporation for certification.

When this information is received, we will continue processing your application. However, staff cannot recommend certification at this time due to questions relating to prior issues with the PSC, incomplete ALEC Price List, and Department of State issues. Staff would also like to know your relationship with Biz-Tel Corporation.
