AT&T Communications of the Southern States, Inc., AT&T Broadband Phone of Florida, Inc., and TCG South Florida, Inc. (collectively, "AT&T") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Confidential Classification, and states the following:

1. On October 18, 2001 during the scheduled hearing in this docket, the Commission requested AT&T's witness, Denise Berger, to provide the name of the Florida AT&T customer experiencing DID problems as Late-filed Exhibit No. 48. This Response contains customer-specific information that is considered confidential and proprietary to AT&T.
2. Pursuant to Rule 25-22.06(3)(a), AT&T is now filing a Request for Confidential Classification for the subject information because the information contained in AT&T's Late-filed Exhibit No. 48 contains customer-specific information that is considered confidential and proprietary to AT&T. Additionally, this information is valuable and AT&T strives to keep it secret. Pursuant to Section 365.183, Florida Statutes, such information is classified as proprietary confidential business information. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

3. AT&T has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.

WHEREFORE, based on the foregoing, AT&T moves the Commission to enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.
