

**TAMPA ELECTRIC COMPANY'S  
MOTION FOR RECONSIDERATION  
OF A PORTION OF ORDER NO. PSC-01-2176-PCO-EI**

Tampa Electric Company ("Tampa Electric" or "the company") respectfully moves the Commission for a reconsideration of that portion of Order No. PSC-01-2176-PCO-EI ("Order No. 01-2176") issued in this proceeding on November 6, 2001 pertaining to the confidentiality of the names of suppliers of energy purchased by Tampa Electric and, as grounds therefor, says:

1. Tampa Electric seeks reconsideration of Order No. 01-2176 only to the extent that it would require Tampa Electric to disclose the names of suppliers of energy purchased by Tampa Electric in the wholesale market. Tampa Electric stated in its Motion for Protective Order that the information FIPUG's Interrogatory No. 28 would require is similar in nature to the information addressed in the company's July 12, 2001 Motion for Protective Order. That July 12 Motion had attached to it an Affidavit of Tampa Electric witness William L. Brown III specifically stating that Florida's wholesale market is entirely bilateral, i.e., all transactions are one on one and treated confidentially. Mr. Brown's Affidavit states:

In addition to market price discovery, a supplier's costs and availability are valuable information to other participants. . . .


Disclosing a supplier's name would enable other participants in the Florida market to determine the supplier's availability.

2. In Order No. PSC-01-2061-CFO-EI, issued October 18, 2001, in this docket the Commission agreed that information revealing the identity of Tampa Electric's wholesale power suppliers is proprietary confidential business information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms. The Commission also held that information about a supplier's identity also appears to be "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Thus, the Commission concluded information about the supplier's identity is entitled to confidential treatment under Section 366.093(3)(d) and Section 366.093(3)(e), Florida Statutes. The supplier information referred to in Order No. 01-2176 is exactly the same type of information the Commission found to be confidential in Order No. 01-2122.

WHEREFORE, Tampa Electric respectfully requests that the Commission reconsider that aspect of its Order No. 01-2176 that would require Tampa Electric to disclose the identity of its suppliers to FIPUG in response to Interrogatory No. 28.


