1. On October 30, 2001, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX code Denials along with Attachments 1, 2, and 3. On that same day, BellSouth also filed a Notice of Intent to Request Specified Confidential Classification for Attachment No. 3, which contains information that is considered confidential and proprietary to BellSouth.
