Dear Ms. Bayo:

On behalf of LightSource Telecom I, LLC ("LightSource"), this letter is to notify the Florida Public Service Commission ("Commission") that LightSource intends to abandon its Certificates of Authority and revoke its price list and tariff. LightSource does not currently provide telecommunications service to any subscribers in State of Florida.

By way of background, LightSource is an Ohio limited liability company headquartered in Cleveland, Ohio. LightSource is authorized to provide resold and/or facilities-based interexchange and local exchange telecommunications service in various states, including Florida. LightSource received its authorization to provide interexchange telecommunications service pursuant to Commission Order No. PSC-01-1304-CO-TI in Docket No. 010333-TI on June 15, 2001 and authorization to provide alternative local exchange telecommunications pursuant to Commission's Order No. PSC-00-2361-CO-TX in Docket No. 000807-TX on December 8, 2000.

LightSource has reappraised the markets into which it will enter and has determined that it will not be entering the market in the State of Florida.

As mentioned above, LightSource does not have any customers in the State of Florida; therefore, there will be no harm to the general public in the state.




