We did respond to the late notice mailed February 21, 2001 by completing and remitting an Interexchange Company Regulatory Assessment Fee Return. The notice referenced our "2000 Regulatory Assessment Fee". At that time we were not aware that there were two applicable regulatory assessment fees. The forms and instruction being so similar in appearance, we apparently mistook them for being two copies of the same form.
