

Needless to say, I find it difficult to justify a 48% increase in water costs over a two year period either by increased operating costs or by a rational capital expenditure program.

I would hope that the Florida Public Service Commission carefully scrutinizes any justification provided by the Florida Public Utilities Company for the proposed rate increase including the disposition of revenues gained from last years 35.6% increase in costs.




