**RE:** Request for Permission from Comptroller's Office to Write-Off the RAFs for the years

2000 and 2001 for PICUS Communications, LLC (TJ286 and TX344).

On August 7, 2001, Docket No. 011040-TP was established to address TJ286 and TX344's failure to remit RAFs for the year 2000. By Order No. PSC-01-2415-PAA-TP, issued on December 12, 2001, the Commission approved the cancellation of TJ286 AND TX344's Interexchange Telecommunications Certificate No. 7190 and Alternative Local Exchange Telecommunications Certificate No. 7189, due to bankruptcy. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2000 and 2001 for TJ286 and TX344.
