Dear Mr. Lores:

This is a follow up to our telephone conversation concerning the cancellation of your pay telephone certificate in the name of Manuel Lores, Jr. d/b/a Allied Payphone Services. The certificate was cancelled in Docket No. 991357-TC on 01/14/00 for not providing the Commission with your updated address and telephone number.

As information, if a certificate is active for any one day during a calendar year, a telecommunications company owes the Regulatory Assessment Fee (RAF) for that year. In this case, the Commission's records show that the 1999 and 2000 RAF has not been paid. The RAF return forms for both years are attached. The RAF is .0015% of a company's intrastate revenues or \$50.00, whichever is greater. In addition, if payment is made after the due date, then statutory penalty and interest charges are applicable. A breakdown of the charges is attached.

Once payment has been received, no further action is required by you since we now have your correct address and phone number and because your certificate is already cancelled.
