

The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on March 25, 2002. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
