In accordance with our recent telephone conference, enclosed is a new Original Sheet No. 12.0, which removes the two tiered gallonage charge for general service customers. You had mentioned revising Original Sheet No. 13.1 to reflect that it is being held for future use; however, I believe that it would be appropriate to simply remove that sheet from the tariff in its entirety.

With regard to the Water Management District's consideration of North Sumter Utility Company's consumptive use permit which was originally scheduled for January 14, 2002; the Water Management District Staff had last minute questions and the matter was deferred from that meeting and is now scheduled for the February 26, 2002 Water Management District Board Meeting. I will advise you of the Board's decision and forward you a copy of the documentation which is ultimately issued.
