

BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files this Second Notice of Intent to Request Specified Confidential Classification and says the following:

1. On March 26, 2002, BellSouth Telecommunications, Inc. filed its Responses to the Staff of the Florida Public Service Commission's ("Staff's") First Set of Interrogatories and First Request for Production of Documents along with a Notice of Intent to Request Specified Confidential Classification. BellSouth's responses to Staff's First Request for Production Nos. 1, 2, 3 and 4 contained confidential business information. Thus, BellSouth filed a Notice of Intent as to these documents. This Second Notice of Intent is being filed today because additional documents responsive to Request for Production No. 4 contain information that is proprietary to BellSouth.

2.
