Staff requests permission to modify its recommendation for Docket No. 020111-SU, which the Commission will take up as Item No. 10 on the April 2, 2002, Agenda. We inadvertently included the wrong language to close the docket, and would like to modify the recommendation as shown below in legislative format:

ISSUE 2: Should this docket be closed?

RECOMMENDATION: ~~If Issue 1 is approved, the tariff should become effective on or after the stamped approval date on the tariff sheets, pursuant to Rule 25-30.475, Florida Administrative Code. If a protest is filed within 21 days of the issuance date of the Order, the tariff should remain in effect with all wastewater only charges held subject to refund pending resolution of the protest, and the docket should remain open. If no timely protest is filed, this docket should be closed upon issuance of the Consummating Order. Yes. If no protest occurs within 21 days of the issuance date of the Order, the Tariff Order will become final upon the issuance of a Consummating Order and the docket should be closed.~~ (COSTNER, ECHTERNACHT)

STAFF ANALYSIS: ~~If Issue 1 is approved, the tariff should become effective on or after the stamped approval date on the tariff sheets, pursuant to Rule 25-30.475, Florida Administrative Code. If a protest is filed within 21 days of the issuance date of the Order, the tariff should remain in effect with all wastewater only charges held subject to refund pending resolution of the protest, and the docket should remain open. If no timely protest is filed, this docket should be closed upon issuance of the Consummating Order. If the Commission approves staff's recommendation in Issue 1, the Tariff Order will become final upon the issuance of a Consummating Order and the docket should be closed.~~
