Dear Mr. Landau:

This is a follow up to your 2001 Regulatory Assessment Fee (RAF) return, along with a check for \$4.14, and your letter dated January 31, 2002, requesting cancellation of your certificate. There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the RAF, including statutory penalty and interest charges. The other is involuntary. If a company is not in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. It should be noted that any balance owed is forwarded to the Comptroller's Office for collection.

Based on the revenues you reported, the company should have paid the minimum \$50.00 by January 30, 2002. Since full payment was not received, the company owes a balance for calendar year 2001 in the amount of \$48.61 (\$45.86 RAF, \$2.29 penalty, and \$0.46 interest) if payment is postmarked by March 1, 2002. The penalty and interest charges continue to accrue. In addition, the company will owe the minimum for the 2002 RAF. Rule 25-4.0161, Florida Administrative Code, provides that if a certificate is active for any one day during a calendar year, then the RAF is owed for that year. Rule 25-24.514, Florida Administrative Code, provides that when requesting cancellation, the company must either pay the current year's RAF or provide a date certain it will be paid. A copy of the 2002 RAF return form is enclosed.
