Dear Mr. Hartley:

The Commission recently received a note from you written on our delinquent notice which stated that you've been out of business for over a year and that you want your certificate cancelled. As information, a certificate remains active until a company requests cancellation in writing or the Commission cancels a certificate on its own motion for a rule violation. I've searched our records, but cannot find record of a previous request for cancellation from you.

Rule 25-4.0161, Florida Administrative Code, provides that if a certificate is active for any one day during a calendar year, the Regulatory Assessment Fee (RAF) is owed for that calendar year. If payment is postmarked after the due date of the RAF, then statutory penalty and interest charges are also applicable. This means that our records show you owe the 2001 and 2002 RAF (both forms enclosed). In addition, our records show that you have a small past due penalty and interest balance that needs to be paid before a voluntary cancellation can be granted (breakdown enclosed). The alternative to a voluntary cancellation is for the Commission to cancel your certificate on its own motion and turn over any unpaid RAFs to collections.

Therefore, based on the above information, I cannot recommend a voluntary cancellation of your certificate unless the past due balance is paid. Please respond in writing by March 31, 2002, and let me know how you wish to proceed. In the meantime, if you have any questions, just let me know. Dear Certificate Holder:

The Division of the Commission's Clerk and Administrative Services has forwarded your account to our office to address the nonpayment of the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 2001, which was due January 30, 2002. The RAFs return form was mailed to you on **December 15, 2001**, and to date, Commission records reflect that payment has not been received.

According to Florida Law, you are required to add interest charges at 12% per annum, and a 5% penalty for each 30-day period or fraction thereof, beyond the due date, up to a maximum of 25% in addition to the delinquent amount due. In addition, pursuant to Section 364.285, Florida Statutes, the Commission is authorized to impose upon any entity subject to its jurisdiction a penalty of not more than \$25,000 for each offense, if such entity is found to have refused to comply with or to have willfully violated any lawful rule or order of the Commission, or any provision of Chapter 364.

Utilities are charged with knowledge of our rules and statutes. Moreover, it is general Commission practice that all utilities that apply for Pay Telephone certificate receive a copy of all applicable rules. Further, in accordance with Section 364.335, Florida Statutes, as part of the application process, utilities provide an affidavit indicating that they have read and understood the applicable rules.

If you wish to request another form, please contact Jackie Knight at the number below. The payment should be identified with the company code and the company's name. Failure to provide payment within 15 days of this notice will result in the establishment of a docket to address your failure to return the RAFs form and pay RAFs in accordance with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code. As specified above, pursuant to Section 364.285, Florida Statutes, the Commission may impose a fine or cancel your telecommunications certificate. Therefore, it is important that you address this matter now.
