

Subject: CLECS – **REVISED** - Electronic Interface Systems Downtime – Release 10.5 and Local Number Portability (LNP) Release 7.0 (Originally posted April 15, 2002)

This is to advise that BellSouth's Encore Release 10.5 and LNP Release 7.0.1, scheduled for May 18 and 19, 2002 will be delayed. During testing of the release, BellSouth recently identified several severity 2 defects that cannot be adequately retested in time to place the release in production this weekend and for which BellSouth does not believe adequate workarounds can be put into place. In order to ensure that the release meets the quality standards committed to by BellSouth and to allow CLECs additional time to test the release, BellSouth has made an internal no-go decision and will delay the release implementation. The tentative plan is to implement the Encore 10.5 and LNP 7.0.1 releases on June 1 and 2, 2002.

The North American Number Council (NANC) Release 3.1 in the Southeast Region will be implemented as scheduled and will make LNP LSR and Number Portability Administration Center (NPAC) processing unavailable from 1:00 AM EDT on May 18, 2002 to 1:00 AM EDT on May 20, 2002.
