


1. On June 6, 2002, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Miami Exchange (Grande), along with Attachments A, B and C. Attachments A and C contain information that is considered confidential and proprietary to BellSouth. BellSouth also filed a Notice of Intent to Request Specified Confidential Classification for Attachment A and C on that same day.
