#### NOTICE OF SETTLEMENT MOTION

Take notice that on July 3, 2002, the Debtors, by counsel, filed a Motion (the "Motion") for Approval of Settlement of Administrative Expenses of the City of Norfolk (the "City"). The purpose of the Motion is to seek court approval for the settlement of administrative claims asserted by the City against the Estate. The Motion proposes an immediate cash payment, totaling \$20,000, to the City, in return for reclassification of the remainder of the post-petition tax claim, or \$25,598.64, as an unsecured, non-priority claim, and the dismissal with prejudice of the City's motion for payment of administrative expenses. All other terms of the settlement with the City are specifically described in the Motion. A true photocopy of the Motion is available from the Court or from counsel for the Debtors, upon request.

Your rights may be affected. You should read the Motion carefully and discuss it with your attorney if you have one. If you do not have an attorney, you may wish to consult one.
