RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2001 and 2002 for Novo Networks Metro Services, Inc. (TJ504).

By Order No. PSC-02-0843-PAA-TI, issued on June 19, 2002, the Commission approved the cancellation of TJ504's Interexchange Telecommunications Certificate No. 7824 due to bankruptcy. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2001 and 2002 for TJ504.
