REIMBURSEMENT OF EXPENSES OF PROFESSIONALS AND (4) LAST DAY FOR
FILING CLAIMS ARISING FROM REJECTION OF EXECUTORY CONTRACTS**

TO ALL HOLDERS OF CLAIMS AND PARTIES IN INTEREST:

Pursuant to Fed. R. Bankr. P. 2002(f)(7) and 3002(c), please take notice that on July 30, 2002 ("Confirmation Date"), the Court entered the *Order Confirming* ("Confirmation Order") *Amended Joint Plan of Liquidation of the Debtor and the Official Committee of Unsecured Creditors* ("Plan").¹

Please take further notice that pursuant to the Confirmation Order and the Plan, the following deadlines have been established for filing certain claims:

a. Administrative Claims

Except as set forth in paragraph b below, any Administrative Claim arising on or after April 1, 2001 through the Confirmation Date must be filed by September 3, 2002 (the "Second Administrative Bar Date") or shall be forever barred. Any Administrative Claim filed by the Second Administrative Bar Date shall be allowed in full and paid as soon as practicable after the Effective Date in accordance with the Plan unless an objection to such claim is filed within 60 days after the Second Administrative Bar Date or such later date as is provided by Order of this Court

b. Applications For Allowance Of Compensation And/Or Reimbursement Of Expenses Of Professionals

All final requests for compensation or reimbursement of Professionals for services rendered prior to the Confirmation Date must be filed and served no later than 45 days after the Confirmation Date, unless otherwise ordered by this Court (the "Professional Fee Bar Date"), or shall be forever barred. Such applications may be later amended to include any fees and costs incurred after the Confirmation Date and prior to the Effective Date.
