

(Verizon) (f/k/a GTE Florida Incorporated) files this petition before the Florida Public Service Commission (Commission) seeking approval of Amendment No. 1 to the interconnection, resale and unbundling agreement with LecStar Telecom, Inc. f/k/a Empire Telecom Services Inc. (LecStar). In support of this petition, Verizon states:

The Verizon/LecStar agreement was approved by the Commission by Order No. PSC-01-0171-FOF-TP issued January 22, 2001 in Docket No. 001665-TP. This Amendment (the "Amendment") to the Interconnection Agreement between Verizon Florida Inc., f/k/a GTE Florida Incorporated and LecStar Telecom, Inc. f/k/a Empire Telecom Services, Inc. for the state of Florida (the "Agreement") is effective June 14, 2001.

Notwithstanding any possible contrary construction of this Agreement, Internet Traffic shall not be eligible for payment of Reciprocal Compensation under this Agreement. The Parties' rights and obligations with respect to any intercarrier compensation that may be due in connection with their exchange of Internet traffic shall be governed by the Order on Remand and Report and Order, In the Matter of Implementation of the Local Competition Provisions in the Telecommunications Act of 1996, Intercarrier Compensation for ISP Bound Traffic, FCC 01-131, CC Docket Nos. 96-98 and 99-68.
