of Overcharges

As you requested, the Finance staff has recalculated the interest on the overcharges due to Optical Telephone Corporation customers. The total refund amount of \$143,179.30 consists of \$140,842.97 in overcharges and \$2,336.33 in interest. The calculation assumes that the overcharges of \$140,842.97 were incurred evenly from September 2001 to May 2002. In addition, staff assumes that principal and interest will be refunded evenly in November 2002. The appropriate interest rate is the average 30-day commercial paper rate for each month. The last available monthly interest rate of 1.735% is used for the future months past October 2002. Attached is a schedule which shows the calculations.
