
ePagos, Inc. wishes to keep its Certificate active and in compliance with Commission rules. We apologize for the oversight in filing this document. While it is true that we have discontinued this segment of our operation, we do not wish to lose our license. We spent a lot of time and effort to secure the license and do not want to see it cancelled. While the segment is not operating at this time- this step was only a temporary measure. Unfortunately, our company has not been immune to the recent economic downturn, but we have stabilized ourselves and would like to grow once it is feasible to do so. We have made changes in our officers and administrative personnel. Perhaps during the change, the filing was inadvertently not filed. However, we have taken the necessary steps to ensure timely and accurate filings of all our required documents. Therefore, we would like to keep the license in good standing so that we may offer the service in the future.

ePagos, Inc. agrees to waive any objection to the administrative cancellation of its certificate should ePagos, Inc. fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, Commission staff will bring the matter to the Commission for consideration.

ePagos, Inc. respectfully proposes to pay \$250.00 as monetary settlement for the violation, which will be paid within 10 business days after the Commission Order is issued.
