I have exchanged e-mails with Ms. Lena Lager (copy attached) concerning the 2001 Regulatory Assessment Fee (RAF). Ms. Lager asked me to fax you the information about a settlement proposal to resolve this docket in order for the company to keep its certificate active and in good standing with the Commission.

The Commissioners are scheduled to vote on this docket at the October 1, 2002 Agenda Conference, to impose a \$500 fine for failure to pay the RAF. A Proposed Agency Action Order is scheduled to be issued by October 21, 2002. After the Order is issued, you will have 20 days to protest the Commission Order by proposing a settlement.
