

FLORIDA COMPETITIVE CARRIERS ASSOCIATION'S
MOTION FOR EXTENSION OF TIME

The Florida Competitive Carriers Association ("FCCA"), through its undersigned counsel, files this Motion for Extension of Time, and states:

1. As presently scheduled, prefiled direct testimony is due in the above dockets on October 18, 2002.
2. Due to case load considerations and other commitments, FCCA moves for an extension of the deadline for the filing of prefiled testimony until and including October 23, 2002, an extension of only five (5) days.
3. By this Motion, FCCA does not seek to alter any other procedural milestone. Dates for the filing of rebuttal testimony, prehearing statements, the prehearing conference, and the hearing date would be unaffected. FCCA notes that even with the change parties will have almost thirty days after receipt of direct testimony within which to prepare and file their rebuttal testimony.
4. FCCA has contacted counsel for Florida Digital Network (FDN), BellSouth Telecommunications, Inc., ITC Deltaom and XO Communication, Inc. FDN supports the motion. BellSouth, XO and ITC do not oppose the motion.

WHEREFORE, FCCA moves for an order extending the time for the filing of direct testimony in the above dockets to and including October 23, 2002.
