On October 21, 2002, the prehearing office issued an order allowing certain noticing provisions to be implemented with regard to BellSouth's Service Continuity Plan. On October 22, 2002, Supra Telecom filed a Motion for Reconsideration of the prehearing officer's decision. Staff notes that another recommendation is currently scheduled to be filed in this docket for consideration on the November 5, 2002, Agenda, which is closely related to the issues to be addressed in this recommendation on Supra's request for reconsideration. Therefore, staff believes that it would be administratively efficient and beneficial to a full representation of the matters at issue if the recommendation on Supra's Motion for Reconsideration is also scheduled for the November 5, 2002, Agenda Conference. Due to time constraints, staff will not, however, be able to complete the recommendation by the regularly scheduled filing date. Therefore, we ask permission to file this recommendation by noon on Tuesday, October 29, 2002.
