Dear Ms. Bayo:

On October 22, 2002, Supra Telecommunications and Information Systems, Inc.'s ("Supra") filed a Motion for Reconsideration of Order No. 02-1454-PCO-TL. Under Rule 25-22.0376(2), Florida Administrative Code, BellSouth's response to that Motion would ordinarily be due today, October 29, 2002.

However, because Supra recently filed for bankruptcy, this proceeding is stayed pursuant to federal law. Consequently, BellSouth is prohibited from filing any response to the Motion for Reconsideration at this time.

The prohibition against filing a response as a result of the bankruptcy filing should not be considered a waiver of BellSouth's right to file a response. Therefore, BellSouth reserves the right to file a response if and when such a filing may become authorized.


