Dear Ms. Blanca Bayo:

This is a response to order No. PSC-02-1443-PAA-IT issued on October 21, 2002, in Docket No. 020751-TI as to our client TotalCom. Please consider this a protest and/or an offer of settlement to resolve this docket.

We would like to advise that TotalCom was delinquent in its payment of assessment due to change in staff responsible for maintaining the license, as well as change in legal representation. We would ask in future that all correspondence be sent to the attention of Nara Martinez at TotalCom America Corporation, 111 NE First Street, Suite 900, Miami, FL 33132.

The company is now aware that the Regulatory Assessment Fee is due by January 30<sup>th</sup> of every year and we hope to avoid this problem in future. The 2001 Regulatory Assessment Return and fee, including penalty and interest charges, in the amount of \$68.50 is enclosed. Please be advised that TotalCom only began obtaining revenue on this license in July 2002, therefore revenues as of December 31, 2001 are \$0.00.

TotalCom agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, it is our understanding that the Commission staff will bring the matter to the Commission for consideration.

The company respectfully requests that the Commission accept its proposal to pay \$100 settlement instead of the \$500 penalty imposed. I understand that if the Commission approves this settlement, the \$100 settlement must be paid within 14 calendar days from the date of issuance of the Order accepting the settlement.
