TO FLORIDA WATER SERVICES CORPORATION**

Pursuant to Florida Administrative Code R.28-106.206 and Florida Rules of Civil Procedure 1.350, Charlotte County by and through its undersigned counsel request Florida Water Services Corporation (FWSC) to produce the following documents for inspection and copying at the office of Knowles, Marks & Randolph, 215 South Monroe Street, Suite 130, Tallahassee, Florida 32301 on or before December 3, 2002 or at such other time and place as may be mutually agreed upon by counsel.

1. On November 8, 2002 the Office of Public Counsel (OPC) filed the "Citizens First Set of Request for Production of Documents to FWSC."
2. On November 22, 2002 the Florida Public Service Commission in Order No. PSC-02-1617-PCO-WS ordered FWSC to respond to OPC's First Set of Request for Production of Documents by November 25, 2002.
3. In order to avoid duplication and to facilitate the requested production of documents, Charlotte County requests that FWSC produce the same documents pursuant to the same terms and conditions as stated in Order No. PSC-02-1617-PCO-WS.
4. Charlotte County realizes that the Commission's order requires FWSC to respond to OPC's discovery request by Monday, November 25, 2002. Charlotte County also realizes that such a response would not be possible in this instance therefore Charlotte County request that FWSC provide a response by Monday, December 2, 2002.


