Dear Mr. Pare:

On April 24, 2002, the Commission received your letter requesting cancellation of your pay telephone certificate since you are no longer in the payphone business. Before I can recommend a voluntary cancellation, the company must comply with Rule 25-24.514(2), Florida Administrative Code, copy enclosed. The Regulatory Assessment Fee (RAF) is applicable if a certificate is active for any one day during a calendar year, even if a company was not operating or had any revenues during that period. A copy of the 2002 RAF return form is enclosed in case you want to go ahead and send in the minimum \$50 RAF. If payment is not made, you must provide a date certain payment will be made.

As information, the alternative to a voluntary cancellation is an involuntary cancellation. The difference between the two types of cancellations is that if the Commission cancels your certificate involuntarily, any unpaid RAFs will be turned over to collections.
