



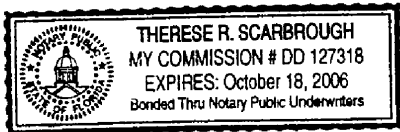

Key Haven Utility Corporation
PSC Docket No. 020344-SU

On November 19, 2002, the Florida Public Service Commission approved interim wastewater rates for Key Haven Utility Corporation. The interim rates will be collected subject to refund, pending the Florida Public Service Commission's final decision regarding final rates. If a refund is ordered, it will include interest based upon the Commission determined factors. The Commission is scheduled to take final action on this case at its February 18, 2003, agenda conference.
