COMMENCEMENT OF CASES.

Petitions for reorganization under Chapter 11 of the Bankruptcy Code are pending in this Court by the Debtors listed above, and orders for relief have been entered. You will not receive notice of all documents filed in this case. All documents filed with the Court, including lists of the Debtors' property and debts, are available for inspection at the Office of the Clerk of the Bankruptcy Court.

## PURPOSE OF CHAPTER 11 FILING.

Chapter 11 of the U.S. Bankruptcy Code enables a debtor to reorganize pursuant to a plan. A plan is not effective unless approved by the court at a confirmation hearing. Creditors will be given notice concerning any plan, or in the event the case is dismissed or converted to another chapter of the Bankruptcy Code. The Debtors will remain in possession of their property and will continue to operate any business unless a trustee is appointed.

## CREDITORS MAY NOT TAKE CERTAIN ACTIONS.

A creditor is anyone to whom a debtor owes money or property. Under the Bankruptcy Code, a debtor is granted certain protection against creditors. Common examples of prohibited actions by creditors are contacting a debtor to demand repayment, taking action against a debtor to collect money owed to creditors or to take property of a debtor, and starting or continuing foreclosure actions or repossessions. If unauthorized actions are taken by a creditor against a debtor, the Court may penalize that creditor. A creditor who is considering taking action against a debtor or the property of a debtor should review § 362 of the Bankruptcy Code and may wish to seek legal advice. **The staff of the Clerk of the Bankruptcy Court are not permitted to give legal advice.**

## MEETING OF CREDITORS.

The Debtors' representative, as specified in Rule 9001(5) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), is required to appear at the meeting of creditors on the date and at the place set forth above for the purpose of being examined under oath. Attendance by creditors at the meeting is welcomed, but not required. At the meeting, the creditors may examine the Debtors and transact such other business as may properly come before the meeting. The meeting may be continued or adjourned from time to time by notice at the meeting, without further written notice to the creditors.

## CLAIMS.

Schedules of creditors have been filed pursuant to Bankruptcy Rule 1007. Any creditor holding a scheduled claim which is **not** listed as disputed, contingent, or unliquidated as to amount may, but is not required to, file a proof of claim in these cases. Creditors whose claims are not scheduled or whose claims are listed as disputed, contingent, or unliquidated as to amount and who desire to participate in the cases or share in any distribution must file their proofs of claim. A creditor who desires to rely on the schedule of creditors has the responsibility for determining that the claim is listed accurately. **Separate notice of the deadlines to file proofs of claim and a form of proof of claim will be provided to the Debtors' known creditors.** Proof of claim forms are also available in the clerk's office of any bankruptcy court. Proof of claim forms are also available from the Court's web site at [www.vaeb.uscourts.gov](http://www.vaeb.uscourts.gov).

ORDER CONFIRMING FIRST AMENDED JOINT PLAN OF LIQUIDATION  
OF PATHNET TELECOMMUNICATIONS, INC. AND PATHNET, INC.

Pathnet Telecommunications, Inc. ("PTI"), Pathnet, Inc. ("PNI") (collectively, the "Debtors"), and the Official Committee of Unsecured Creditors (the "Committee," and collectively with the Debtors, the "Proponents"), have filed the First Amended Joint Plan of Liquidation of Pathnet Telecommunications, Inc. and Pathnet, Inc. (the "Plan") and sought confirmation of the Plan<sup>1</sup>.

NOW, THEREFORE, based upon (i) all of the evidence proffered or adduced at, memoranda and objections filed in connection with, and arguments of counsel made at, the confirmation hearing, and (ii) the entire record herein; and after due deliberation thereon; and good cause appearing therefor;

IT IS HEREBY FOUND AND DETERMINED AS FOLLOWS<sup>2</sup>:

1. Jurisdiction and Venue (28 U.S.C. §§ 157, 1334 and 1408). This Court has jurisdiction over the cases pursuant to 28 U.S.C. §§ 157 and 1334. Venue is proper pursuant to

28 U.S.C. § 1408. Confirmation of the Plan is a core proceeding under 28 U.S.C. § 157(b)(2), and this Court has exclusive jurisdiction to determine whether the Plan complies with the applicable provisions of the Bankruptcy Code and should be confirmed.

2. Judicial Notice. This Court takes judicial notice of the docket of these cases maintained by the Clerk of the Court and/or its duly-appointed agent, including, without limitation, all pleadings and other documents filed, all orders entered, and all evidence and arguments made, proffered or adduced at, the hearings held before the Court during the pendency of these cases.

3. Transmittal and Mailing of Materials; Notice. The Disclosure Statement, Plan, Ballots, and Confirmation Hearing Notice were transmitted and served in compliance with the Voting Procedures Order entered by this Court on January 18, 2002, and the Bankruptcy Rules, and such transmittal and service were adequate and sufficient.

4. Plan Compliance With Bankruptcy Code (11 U.S.C. § 1129(a)(1)). As specifically set forth below, the Plan complies with the applicable provisions of the Bankruptcy Code, thereby satisfying section 1129(a)(1) of the Bankruptcy Code.

a. Proper Classification (11 U.S.C. §§ 1122 and 1123(a)(1)). The Plan designates five classes of Claims and Equity Interests for each of the Debtors. The Claims and Equity Interests placed in each class are substantially similar to other Claims or Equity Interests, as the case may be, in each such class. Valid business, factual and legal reasons exist for separately classifying the various classes of Claims and Equity Interests created under the Plan. The Plan therefore satisfies sections 1122 and 1123(a)(1) of the Bankruptcy Code.

b. Specify Unimpaired and Impaired Classes (11 U.S.C. § 1123(a)(2) and (3)).  
The Plan specifies that PTI Class 1 and PNI Class 1 are not impaired under the Plan, thereby

satisfying section 1123(a) (2) of the Bankruptcy Code. The Plan designates PTI Classes 2, 3, 4 and 5, and PNI Classes 2, 3, 4 and 5 as impaired and specifies the treatment of Claims and Equity Interests in those classes, thereby satisfying section 1123(a)(3) of the Bankruptcy Code.

c. No Discrimination (11 U.S.C. § 1123(a)(4)). The Plan provides for the same treatment by the Debtors for each Claim or Equity Interest in each respective class unless the holder of a particular Claim or Equity Interest has agreed to a less favorable treatment of such Claim or Equity Interest, thereby satisfying section 1123(a)(4) of the Bankruptcy Code.

d. Implementation Of Plan (11 U.S.C § 1123(a)(5)). The Plan provides adequate and proper means for its implementation and therefore satisfies section 1123(a)(5) of the Bankruptcy Code.

e. Nonvoting Equity Securities (11 U.S.C. § 1123(a)(6)). The Plan provides for the dissolution of the Debtors, therefore 1123(a)(6) of the Bankruptcy Code is inapplicable.

f. Selection of Officers, Directors and Other Persons (11 U.S.C. § 1123(a)(7)). Pursuant to the Plan, the Committee has designated Daniel Gray to serve as the Liquidating Agent of each of the Liquidating LLCs. In addition, the Plan provides for the dissolution of the Debtors. Therefore, the Plan is consistent with the interests of creditors and with public policy, and satisfies, to the extent applicable, section 1123(a)(7) of the Bankruptcy Code.

g. Compliance with Applicable Provision of the Code (11 U.S.C. § 1129(a)(1)). The Plan complies with the applicable provisions of the Bankruptcy Code thereby satisfying section 1129(a)(1) of the Bankruptcy Code.

h. Proponents' Compliance with Bankruptcy Code (11 U.S.C. § 1129(a)(2)). The Proponents have complied with the applicable provisions of the Bankruptcy Code, thereby satisfying section 1129(a)(2) of the Bankruptcy Code.



i. Proponents' Good Faith (11 U.S.C. § 1129(a)(3)). The Proponents have proposed the Plan in good faith and not by any means forbidden by law.

5. Payments For Services or Expenses (11 U.S.C § 1129(a)(4)). Any payment made or to be made by the Proponents or the Debtor for services or for costs and expenses in or in connection with these cases, or in connection with the Plan prior to the Effective Date and incident to these cases, has been approved by, or is subject to the approval of, the Court as reasonable, thereby satisfying section 1129(a)(4) of the Bankruptcy Code.

6. Directors, Officers, and Insiders (11 U.S.C. § 1129(a)(5)). The Proponents have complied with any applicable provision of section 1129(a)(5) of the Bankruptcy Code.

7. No Rate Changes (11 U.S.C. § 1129(a)(6)). The Debtor will have no continuing business operations or activities after confirmation and consummation of the Plan, and therefore section 1129(a)(6) of the Bankruptcy Code is not applicable.

8. Best Interest of Creditors Test (11 U.S.C § 1129(a)(7)). The Plan satisfies section 1129(a)(7) of the Bankruptcy Code in that each holder of a Claim or Equity Interest in an impaired class either (i) has accepted the Plan, or (ii) will receive or retain under the Plan, on account of such Claim or Equity Interest, property of a value, as of the Effective Date of the Plan, that is not less than the amount that it would receive if the Debtors were liquidated under Chapter 7 of the Bankruptcy Code on such date.

9. Acceptance By Certain Classes (11 U.S.C. §1129(a)(8)). PTI Class 1 and PNI Class 1 are classes of unimpaired Claims that are conclusively presumed to have accepted the Plan under section 1126(f) of the Bankruptcy Code. PTI Class 2, although solicited, did not vote, therefore PTI Class 2 neither accepted nor rejected the Plan. PNI Class 2 has voted to reject the Plan . PTI Class 3 and PNI Class 3 have voted to accept the Plan in accordance with

section 1126(c) of the Bankruptcy Code. PTI Classes 4 and 5, and PNI Classes 4 and 5 are not entitled to receive or retain any property of value under the Plan and therefore are deemed to have rejected the Plan pursuant to section 1126(g) of the Bankruptcy Code. Although section 1129(a)(8) of the Bankruptcy Code has not been satisfied with respect to PTI Classes 4 and 5 and PNI Classes 2, 4 and 5, the Plan is confirmable because the Plan satisfies section 1129(b) of the Bankruptcy Code with respect to those classes.

**10. Treatment of Administrative and Priority Claims (11 U.S.C.**

**§ 1129(a)(9)**). The treatment of Administrative Claims and Priority Claims under the Plan satisfies the requirements of section 1129(a)(9) of the Bankruptcy Code.

**11. Acceptance by Impaired Class (11 U.S.C. § 1129(a)(10))**. PTI Class 3 and

PNI Class 3 are impaired classes of Claims that have voted to accept the Plan determined without including any acceptance by “insiders,” thus satisfying section 1129(a)(10) of the Bankruptcy Code.

**12. Feasibility (11 U.S.C § 1129(a)(11))**. The Plan provides for the winding-up

of the Debtors, the transfer of assets to the Liquidating LLCs for the benefit of holders of Allowed Unsecured Claims and the distribution to creditors in accordance with the terms of the Plan. Therefore, to the extent applicable, the Plan satisfies section 1129(a)(11) of the Bankruptcy Code.

**13. Payment of Fees (11 U.S.C. § 1129(a)(12))**. All fees payable under

28 U.S.C. § 1930 have been paid or will be paid on the Effective Date pursuant to the Plan, thereby satisfying section 1129(a)(12) of the Bankruptcy Code.

**14. Retiree Benefits (11 U.S.C. § 1129(a)(13))**. The Debtors had no pre-

bankruptcy or post-bankruptcy program in place to pay “retiree benefits”. Accordingly, the

Debtors have no obligation to continue any such program under section 1129(a)(13) of the Bankruptcy Code.

15. Fair and Equitable (11 U.S.C. § 1129(b)). PTI Classes 4 and 5, and PNI Classes 2, 4 and 5 (collectively the “Rejecting Classes”) are impaired classes that have rejected or are deemed to have rejected the Plan. These are the only classes that have not accepted, or been deemed to have accepted, the Plan. The holders of PNI Class 2 Claims will receive the indubitable equivalence of such claims under the Plan. The holders of Claims or Equity Interests junior to PNI Classes 4 and 5, or PTI Classes 4 and 5, will not receive or retain any property under the Plan on account of such junior Claims or Equity Interests. Therefore, the Plan is fair and equitable with respect to each of the Rejecting Classes within the meaning of section 1129(b) of the Bankruptcy Code. The Plan therefore may be confirmed notwithstanding the failure to satisfy section 1129(a)(8) of the Bankruptcy Code.

**NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:**

1. Confirmation. The Plan is approved and confirmed under section 1129 of the Bankruptcy Code. The terms of the Plan are incorporated by reference into and are an integral part of this Order.

2. Objections. All objections to confirmation of the Plan that have not been withdrawn, waived, or settled are overruled.

3. Plan Classification. The classification of Claims and Equity Interests under the Plan shall be governed solely by the terms of the Plan. The classifications set forth on the Ballots tendered to or returned by creditors in connection with voting on the Plan (i) were set forth on the Ballots solely for purposes of voting to accept or reject the Plan, (ii) do not necessarily represent, and in no event shall be deemed to modify or otherwise affect, the actual

classification of such Claims under the Plan for distribution purposes, and (iii) shall not be binding on the Debtors, their respective estates, the Liquidating LLCs, or any other Person.

4. Binding Effect. Pursuant to section 1141 of the Bankruptcy Code, the provisions of the Plan (including the exhibits to, and all documents and agreements executed pursuant to, the Plan) shall be binding on (i) the Debtors, (ii) the Liquidating LLCs, (iii) all holders of Claims against and Equity Interests in the Debtors, and (iv) each of their respective heirs, successors, assigns, trustees, executors, and administrators.

5. Termination of Automatic Stay. Except as otherwise provided in any other order of this Court, all injunctions or stays provided for under sections 105 or 362 of the Bankruptcy Code or otherwise, and extant on the Confirmation Date, shall remain in full force and effect until the Effective Date of the Plan.

6. Rejected Contracts and Leases. Except as otherwise provided in the Plan, or in any contract, instrument, release, or other agreement or document entered into in connection with the Plan, all of the executory contracts and unexpired leases to which either of the Debtors is a party, to the extent such contracts or leases are executory as of the Confirmation Date, are rejected pursuant to section 365 of the Bankruptcy Code and the Plan, except those contracts or leases (i) previously assumed or rejected by the Debtors, or (ii) which expired or terminated pursuant to their own terms during the pendency of these cases. If the rejection of an executory contract or unexpired lease pursuant to the Plan gives rise to a Claim by the non-debtor party or parties to such contract or lease, such Claim shall be forever barred and shall not be enforceable against the Debtors, their respective estates, the Liquidating LLCs, or their respective successors, assigns or properties unless a proof of claim is filed and served in accordance with Section 13.2 of the Plan.

7. Liquidating LLCs. Except as expressly provided in the Plan, in accordance with section 1123(b) of the Bankruptcy Code, the Liquidating LLCs or their successors or substitutes (as provided in Section 9.6 of the Plan) may retain and enforce any claims, rights and causes of action, whether arising before or after the Petition Date, that the Debtors or their respective estates may hold against any entity or person. Pursuant to the terms of the Plan, the Liquidating LLCs or their successors or substitutes may pursue such claims, rights or causes of action, as appropriate and may pursue, abandon, settle or release any or all such claims, rights and causes of action as they may deem appropriate.

8. Exculpation. None of the Debtors, the members of the Committee, the Liquidating Agent, the Liquidating LLCs, or any of their respective current or former officers, directors, employees or agents shall have or incur any liability to any Entity for any act or omission in connection with or arising out of these cases, the pursuit of confirmation of the Plan, the consummation of the Plan, or the administration of the Plan or the property to be distributed under the Plan, except for gross negligence or willful misconduct, and in all respects the Debtors, the members of the Committee, the Liquidating Agent, the Liquidating LLCs, or any of their respective current or former officers, directors, employees or agents shall be entitled to rely upon the advice of counsel with respect to their duties and responsibilities under the Plan.

9. Post-Effective Date Professional Fees. Notwithstanding Section 12.11 of the Plan, professional fees and expenses incurred by the Debtors, the Committee, the Bond Trustee, the Liquidating Agent and the Oversight Committee after the Effective Date in connection with the effectuation of the Plan and through the date of the decree closing the respective case shall be subject to approval by this Court.

10. Exemption From Certain Taxes. Pursuant to section 1146(c) of the Bankruptcy Code, the issuance, transfer, or exchange of any security, or the making, delivery, filing, or recording of any instrument of transfer under the Plan, shall not be taxed under any law imposing a stamp tax or similar tax.

11. Payment of Fees. All fees payable by the Debtors under 28 U.S.C. § 1930 shall be paid on or before the Effective Date.

12. Retention of Jurisdiction. This Court shall retain jurisdiction over all matters arising out of, and related to, the cases and the Plan in accordance with sections 105(a) and 1142 of the Bankruptcy Code, and Article 14 of the Plan.

13. Exemption from Securities Laws. Pursuant to section 1145(a)(1) of the Bankruptcy Code, the offer and sale of the interests in the Liquidating LLCs pursuant to the terms of the Plan are exempt from Section 5 of the Securities Act of 1933, as amended, and from any state or local law requiring registration for the offer or the sale of securities or the registration or licensing of an issuer of, underwriter of, or broker or dealer in, a security.

14. Confirmation Order Controlling. In the event of any direct conflict between the Plan and this Order, the terms of this Order shall control.
