Dear Mr. Pirko:

On December 23, 2002, the Commission received your letter dated December 18th requesting cancellation of InterNext's IXC certificate in Florida. Before a docket can be established to grant the company a voluntary cancellation, the company must comply with Rule 25-24.474, Florida Administrative Code. Your letter complies with all sections of the rule except 25-24.474(2)(a), Florida Administrative Code, copy enclosed.

The Regulatory Assessment Fee is assessed if a certificate is active for any one day during a calendar year. The Regulatory Assessment Fee is .0015% of a company's intrastate revenues or \$50.00, whichever is greater. The 2002 Regulatory Assessment Fee is due by January 30, 2003. Since it is not yet past due, the company either needs to go ahead and pay the fee or provide a date certain it will be paid.

If payment of the Regulatory Assessment Fee is paid by January 30th, the effective date of InterNext's cancellation will be December 23, 2002, which means the company will not owe the 2003 Regulatory Assessment Fee. A copy of the 2002 Regulatory Assessment Fee return form is also enclosed.

Therefore, based on the above information, I cannot recommend a voluntary cancellation of the company's certificate unless the company fully complies with Rule 25-24.474, Florida Administrative Code. Please let me know how InterNext wishes to proceed by January 30, 2003.

25-24.474 Cancellation of a Certificate.

(1) The Commission may on its own motion cancel a company's certificate for any of the following reasons:

- (a) Violation of the terms and conditions under which the authority was originally granted;
- (b) Violation of Commission rule or order; or
- (c) Violation of Florida Statutes.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.

- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (c) A statement on treatment of customer deposits and final bills.
- (d) Proof of individual customer notice regarding discontinuance of service.

(3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).

Internext Communications wishes to withdraw all tariff filings and approvals it has been granted in Florida relating to providing telecommunications services in Florida.


The effective date for this filing is 12/31/02, and Internext should no longer be liable for any taxes, fees, or assessments after that date.
