## CASE BACKGROUND

On January 18, 2001, Ms. Charo Rojo contacted the Division of Consumer Affairs, complaining that her November/December electric bill was estimated, rather than based on an actual reading of the meter. Ms. Rojo also wanted her meter checked because of high electric bills. Florida Power & Light (FPL) was contacted and they explained that they could not gain access to the meter for the questioned bill because of a locked six foot wooden fence. Therefore, it was necessary to estimate those particular bills. FPL contacted Ms. Rojo and reviewed with her the account in question.

On March 7, 2001, the complaint of Ms. Rojo was reopened as a result of the following allegations:

(1) She is disputing her account in the amount of \$903.38.
