Pursuant to staff request, I am writing to provide an explanation regarding NETEL, Inc.'s failure to file its RAF reports for 1999 and 2000. When the company obtained its IXC authority, it initially filed its RAF reports. The company went through management and structural changes, including a sale of its customer base, in 1999 and 2000. The company recently entered into an agreement with an outside service company to complete necessary reports to retain its IXC certifications. Prior to hiring the outside compliance management firm, the notices from the Commission regarding the delinquent reports were not properly handled, and "fell through the cracks". The situation has been rectified, and all future reports should be timely filed.
