**ORDER GRANTING DEBTOR'S MOTION TO  
ESTABLISH NOTICE AND SERVICE PROCEDURES**

THIS CAUSE came before the Court on the 29<sup>th</sup> day of January, 2003, in Orlando, Florida, upon *Debtor's Motion to Establish Notice and Service Procedures* (the "Motion") (Doc. No. 8). The Court having considered the Motion, and it appearing that the relief sought in the Motion is in the best interest of the Debtor, its estate and creditors and interest holders thereof, and it appearing that the relief requested in the Motion will promote the Debtor's reorganization by preserving assets that otherwise would be consumed by unnecessary copying, postage, and related expenses, and after due deliberation and good and sufficient cause appearing therefor, it is

**ORDERED** as follows:

1. The Motion as modified by this Order is granted.
2. Pursuant to Rule 2002(m) of the Federal Rules of Bankruptcy Procedure, the Debtor shall establish a service list (the "ATN Service List") which shall include the following parties: (a) the Debtor and its bankruptcy counsel; and (b) the United States Trustee; and (c) members of the creditors' committee and its counsel, when and if one is formed; or (d) the twenty (20) largest unsecured creditors of the Debtor as set forth in the list to be filed pursuant to Rule 1007(2) of the Federal Rules of Bankruptcy Procedure; and (e) the District Director of the Internal Revenue Service for this district; and (f) the Office of the United States Trustee for the

Middle District of Florida; and (g) those persons who file and serve a notice of appearance and request for service in this Chapter 11 case pursuant to Rules 2002, 3017(a) and/or 9010 of the Federal Rules of Bankruptcy Procedure. **The parties in interest required to receive notice of proceedings in the Chapter 11 case would be limited to those parties included on the ATN Service List and any other persons whose rights or interests will be directly affected by a specific pleading or proceeding in the case ("Other Affected Parties"). ACCORDINGLY IF YOU WISH TO RECEIVE NOTICE OF FUTURE PROCEEDINGS YOU MUST FOLLOW THE PROCEDURES SET FORTH IN THIS ORDER.** Except for "Material Matters" (defined below), notice as to all pleadings, notices and other papers that relate to the Chapter 11 case can be limited to the ATN Service List and to Other Affected Parties.

3. Service of the following notices and pleadings constituting Material Matters will not be limited pursuant to this Motion:

- (a) notice of the deadline to file proofs of claims pursuant to Rule 3003(c) of the Federal Rules of Bankruptcy Procedure;
- (b) any motion to dismiss or convert the Chapter 11 cases and notice of any hearing related thereto;
- (c) any motion to appoint a trustee or examiner and notice of any hearing related thereto;
- (d) notice of the time fixed for filing objections to and any hearing to consider the approval of a disclosure statement or the confirmation of any plan of reorganization;
- (e) any disclosure statement approved by the Court and any plan of reorganization related thereto, together with ballots for accepting or rejecting such plan and notice of the time within which acceptances or rejections of such plan must be filed;
- (f) notice of the time fixed for accepting or rejecting a proposed modification of a plan of reorganization.
- (g) this Order Granting Debtor's Motion To Establish Notice Procedures; and

(h) notice of commencement of this case.

4. Upon receipt of each written and filed notice of appearance and request for service in accordance with Rules 2002, 3017(a) and/or 9010 of the Federal Rules of Bankruptcy Procedure, counsel for the Debtor shall (i) update the ATN Service List to include such party requesting notice, and (ii) commence service to such additional party no later than the fifth business day following the actual receipt by counsel for the Debtor of such notice and request.

5. Additionally, counsel for the Debtor shall file an amended ATN Service List on or before the tenth day of any month following which counsel for the Debtor have updated the ATN Service List. Subject to the exceptions constituting Material Matters described above, the ATN Service List shall be the official list for service in the Chapter 11 cases whenever notice of a proceeding is required by the Bankruptcy Code or any Federal Rule of Bankruptcy Procedure or Local Bankruptcy Rule to be given to creditors or parties in interest. The ATN Service List will be presumed to comply with due process requirements and to be consistent with service and notice requirements under the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure and Local Bankruptcy Rules, other than when used in relation to Material Matters; however, nothing in this Order will preclude the Debtor or any other party in interest from seeking to lengthen or shorten notice periods if the facts and circumstances so warrant.

6. Any party in interest may be added to the ATN Service List by both filing and serving upon counsel for the Debtor an appropriate notice of appearance and request for service under Rules 9010, 2002 and/or 3017(a) of the Federal Rules of Bankruptcy Procedure. Further, any party on the ATN Service List, may serve a written request upon counsel for the Debtor that it be removed from the ATN Service List.

7. Any party in interest may also request that notices be sent to a different address by both filing with the Court and serving on the Debtor's counsel a request for change of address.

Similarly, counsel for any of the parties in interest, if other counsel is substituted in their place, may report this substitution and request that notices be sent to the new counsel by both filing with the Court and serving the Debtor's counsel a request for change of address.

8. The Debtor shall serve papers to those on the ATN Service List but is authorized to eliminate the ATN Service List from the service of each paper sent to interested parties. The Debtor is authorized to send only one to notice on a creditor who may be listed multiple times as a result of different account numbers and addresses except that if a creditor is shown with different account numbers and a different address, a notice shall be sent to each address. The Debtor shall file a Certificate of Service, attaching the ATN Service List and indicating the parties upon whom the referenced document was served. The Debtor shall file the Certificate of Service with the Court and serve a copy on the United States Trustee's Office.

9. Any party that wishes to receive notices exclusively via e-mail may serve a written request to that effect on Debtor's counsel. Thereafter no hard copy need be served on that party.

10. Counsel for the Debtor is directed to serve a copy of this Order and the initial version of the ATN Service List upon the entire creditor matrix and to file promptly a certificate of service evidencing compliance herewith.
