Dear Mr. Williams:

I am submitting this letter in response to your inquiry to Mr. Gregg Sayre regarding the application of Florida Administrative Code Section 25-4.118 and the unauthorized change of a service provider. Frontier Communications of America, Inc. ("FCA") and Citizens Telecommunications Company ("CTC") do not believe Section 25-4.118 is applicable to the proposed transaction.

Following the proposed merger, FCA and CTC will retain their existing separate preferred interexchange carrier codes ("PIC"). Customers will continue to be served in the same manner they are served today, in terms of the rates and services they are provided. For the customers currently provided service by FCA, the transaction will be transparent. FCA customers will retain the same existing PIC selection for both IntraLATA and InterLATA toll services. For customers currently provided service by CTC, the only change will be to the name of the entity providing long distance service. CTC customers will retain the same existing PIC selection for both IntraLATA and InterLATA and InterLATA toll services.
