## SECOND JOINT MOTION FOR EXTENSION OF TIME

NOW comes Sprint Communications Company Limited Partnership ("Sprint") and Verizon Florida Inc. (Verizon), who jointly ask this Commission for an additional fourteen (14) day extension of time, or until February 28, 2003, in which to execute and file an interconnection agreement. Pursuant to Order No. PSC-03-0048-FOF-TP, the parties are required to file a final executed agreement with the Commission on February 6, 2003. The Commission granted the parties first request to extend that date to February 14 2003 in Order No. 03-0212-PCO-TP. The parties continue to work together to finalize the agreement, but need additional time to negotiate the final agreement. As both parties are seeking this second extension, no party will be prejudiced by the granting of an additional fourteen (14) days in which to file a final interconnection agreement with the Commission.

WHEREFORE, for the foregoing reasons, Sprint and Verizon respectfully request that this Commission grant them an addition fourteen (14) days, or until February 28, 2003, in which to file an executed, final interconnection agreement.
