**SUPPLEMENT TO  
JOINT PETITION FOR APPROVAL OF TERRITORIAL AGREEMENT**

The City of Ocala, Florida d/b/a Ocala Electric Utility (OEU), on behalf of itself and the Sumter Electric Cooperative, Inc. (SECO), by and through its undersigned attorney, hereby files this Supplement to Joint Petition for Approval of Territorial Agreement and in support thereof states as follows:

1. On February 3, 2003, OEU and SECO filed their Joint Petition for Approval of Territorial Agreement (Joint Petition), but did not submit a general highway county map depicting the boundary lines established by the territorial agreement for which OEU and SECO seek approval. Rule 25-6.0440(1) of the Florida Administrative Code requires an official Florida

Pursuant to Rule 25-6.0440(1) and the transmittal letter filed with the Joint Petition, attached is a general highway county map of Marion County, depicting the boundary lines established by the territorial agreement between OEU and SECO dated September 24, 2002. The attached general highway county map is prepared by the City of Ocala and Marion County, who, in turn, submit it to FDOT for its use.



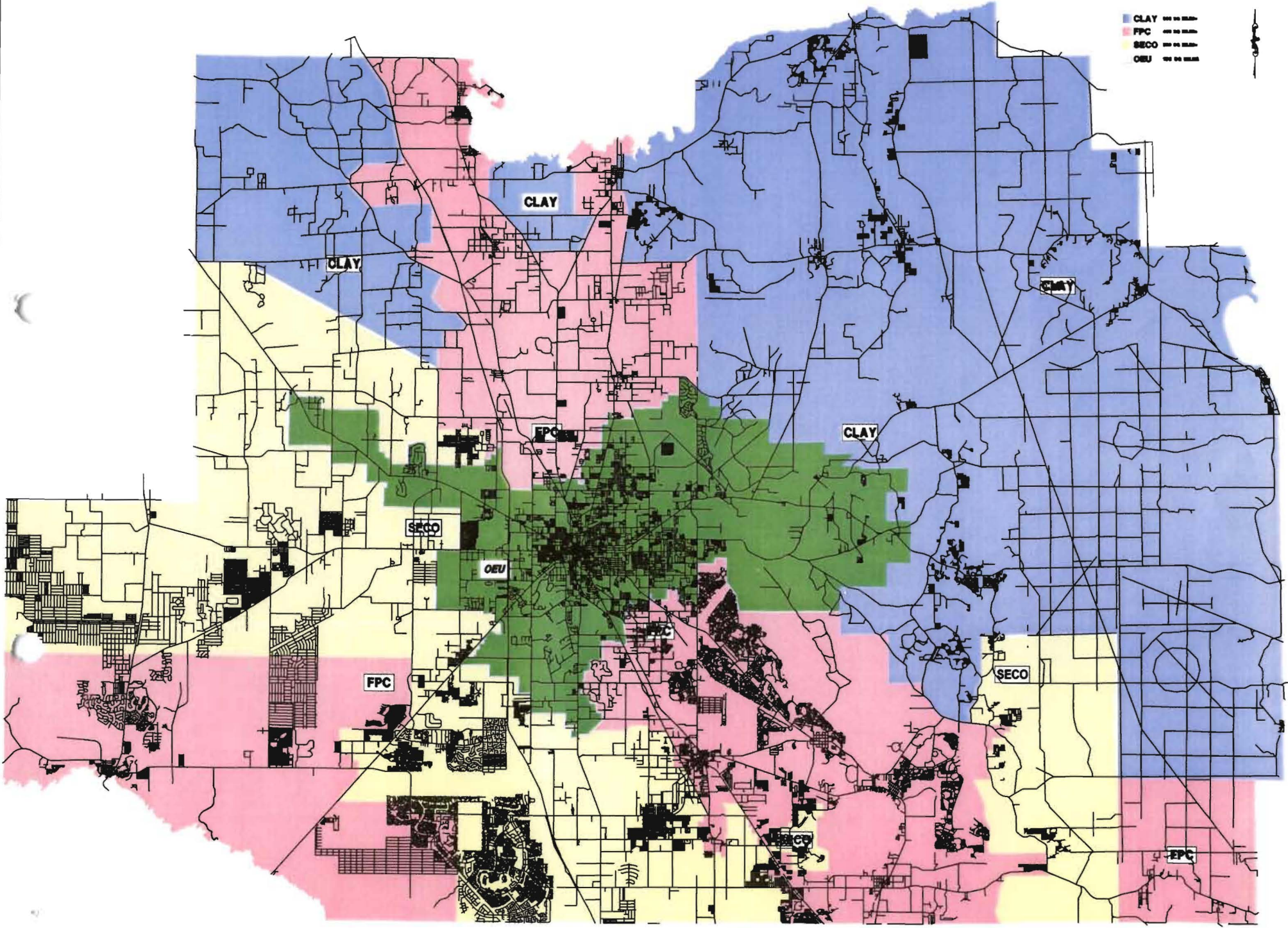
