RE: **Closure of Docket No. 020668-TI - Compliance Investigation of Christian Telecom Network, LLC for Apparent Violation of Rule 25-24.470, F.A.C., Certificate of Public Convenience and Necessity Required, and Rule 25-4.043, F.A.C., Response to Commission Staff Inquiries.**

Order No. PSC-02-1151-PAA-TI, issued August 23, 2002, penalizes Christian Telecom Network, LLC in the amount of \$35,000, and states that if Christian Telecom Network, LLC fails to timely protest the Commission's PAA order, Docket No. 020668-TI shall be closed upon receipt of the payment of the penalty, or upon referral of the penalty to the Office of the Comptroller (now known as the Department of Financial Services). The company failed to file a protest to the Commission's PAA order, and consequently, Consummating Order No. PSC-02-1267-CO-TI was issued on September 16, 2002, making Order No. PSC-02-1151-PAA-TI, effective and final. The payment was not received as ordered, and on February 14, 2003, the amount of the penalty (\$35,000) was referred to the Department of Financial Services. Accordingly, this docket should now be closed.
