Page 6, last line of first paragraph in Staff Analysis; Delete the period and add "and the capacity cost recovery offset which Staff addresses in Issue 1".

Page 8, 4th full paragraph, 2nd to last line: delete "of this increase in sales".

Page 13, 2nd and 3rd to last lines of last paragraph: Replace "typical ratepayer's" with "a 1,000 KWH" and insert "(residential class only)" after "bill".

FPL RECOMMENDATION (Item No. 11)

Page 7, 2nd to last line: Replace "Attachment B" with "Attachment A".

Page 9, 1st line of last paragraph: Replace "Attachment B" with "Attachment A".

Page 10, 1st line of 1st full paragraph: Replace "Attachment B" with "Attachment A".

Page 10, 1st line of 2nd full paragraph: Replace "Attachment B" with "Attachment A".

Page 11, 1st line of last paragraph: Insert "of the 2002 underrecovery" after "recovery".

Page 13, 2nd line of first full paragraph: Replace "2002" with "2001".

Page 13, 3rd to last line and last line of first full paragraph: Replace "maximum" with "minimum" and replace "diminished" with "increased".

Page 16, 2nd and third to last lines: Replace "the typical ratepayer's" with "a 1,000 kWh" and insert "(residential class only)" after "bill".

Page 18, Table 2, header in first column: Replace "Month in 2001" with "Month in 2003"

TECO RECOMMENDATION (Item No. 11A)

Page 2, 1st full paragraph, 2nd line: Replace second "from" with "of".

Page 8, 3rd full paragraph, last line": Insert "early" after "operations".
