
Dear Jackie:

I was recently informed by Kathy Kaproth of the Commission staff that the above-referenced Utility was delinquent in payment of regulatory assessment fees from the year 2000 which total with all penalties and interest \$155.59 for water and \$109.90 for wastewater. My client purchased this system out of foreclosure and as such, we believe there is some question about whether we are truly responsible for the year 2000 regulatory fees.
